- Support the development of new initiatives that design out waste and pollution in priority products*.
- Encourage voluntary initiatives to become government accredited.
- Address barriers to industry and business investment and consumer participation through applied research.
- Identify new stewardship measures, innovations and interventions, including circular design processes to facilitate and accelerate waste avoidance.



Independent information and advice

- Update and enhance the Product Stewardship Gateway and assessment framework to improve public reporting and government and business decision making.
- Report to the federal environment minister on product stewardship priorities.
